- scanning for ad-ware, spy-ware, and malicious code. And,
- removal of malicious code including registry entries.

Protection Strategy

Having provided the customer with a secure personal computer, a protection strategy will be provided. This strategy could be as simple as scheduling of regular software updates, virus scans, and security testing. However, depending on the customer hardware/software/connection configuration additional comments may be made concerning:

- IP addresses,
- firewall strategies,
- database encryption,
- password storage, and
- countermeasures.

In addition, comments on secure web surfing, e-mail approaches, phishing identification and spam control will be made.
